# Message from the President

I was also very pleased to be in the company of EHA (WA) representatives Ms Toni Hannelly from Curtin University and Mr Vic Andrich EHA(WA) State President, who presented the formal bid for the 17th World Congress to be held in Perth, Western Australia. The bid was formally accepted at the Council meeting, and we look forward to welcoming hundreds of delegates from around the world to Perth in May 2024. Whether you are an officer, manager, educator or other environmental health professional I encourage all members from around Australia to consider making the pilgrimage to Perth for what will be a great opportunity to showcase our profession on the world stage.

It really is conference season at the moment, with the National Aboriginal and Torres Strait Islander Environmental Health Conference kicking off in Darwin this week as I write. EHA is a proud sponsor of this important and pragmatic event, which hosts contributions from aboriginal communities around Australia and research and practical papers on real grass roots environmental health. The EHA(Qld) State Symposium is also to be held in Dalby Queensland next week.

And I also look forward to seeing many of you at our 45 th National Conference at Country Club Tasmania in Launceston Monday 26th To Friday 30th September 2022. The conference entitled Environmental Health - Celebrating Triumphs and Tribulations will bring together a great collection of speakers and research nationally and internationally on a variety of topics. Following the difficulties of Covid19 for such events over the last three (3) years, this is again a great opportunity for Members to participate.

I note the recent workforce summit in Canberra and the announced changes to skilled migration. Whilst this will not solve workforce shortages, it is a pleasing step which may allow some easing of the shortages we are experiencing in the environmental health profession. As I mentioned in the last newsletter EHA has been lobbying for the past three years for an environmental health workforce study. I again encourage all Managers to consider, particularly our post graduate courses, for cadet internship and traineeship opportunities within your organisation and recommend that you contact our educators if pursuing such opportunities. I would also like to thank Director, Dr Kirsten Ross and her Flinders University staff, for their work to date surveying Members regarding this important issue. EHA is currently exploring avenues to further develop the workforce project.

As we move into spring, the grip of the current flu season will hopefully ease and with it the pressure on primary health care. From an environmental health perspective though, there is still much to do. With the oncoming spring and summer seasons, with again likely heavy rainfall events along the East coast, and seasonal mosquito breeding and other issues in many areas, this is no time for complacency within our communities. The proliferation of diseases and overseas impacts from Monkeypox, continuing Covid19 management and the potential for foot and mouth disease reaching Australia from Indonesia, are all matters that we are rightfully concerned about. Although the latter wont directly impact human health it would be potentially catastrophic for our regional and farming communities, many of which are just getting back on their feet after the impact of floods, cyclones, bushfires and Covid19.

On a more positive front, EHA in conjunction with the NZIEH and other associations from around the world will this year participate in a podcast to be recorded and circulated to celebrate World Environmental Health Day on 26 th September. I encourage Members to participate in future events or view recordings such as the WEHD podcast, to stay in touch with contemporary issues confronting us all.

# **Environmental health essential in an Australian CDC**

One of the positive aspects of the conversation that the PHAA has been having around the formation of a Centre for Disease Control (CDC) has been the recognition that a CDC needs to have a broader scope than solely that of communicable disease control. The purpose of this article is to explore the inclusion of an environmental health focus in the Centre.

These are my personal reflections and observations having spent many years in the field of environmental health at the state and national level, including as a state director of environmental health programs and chair of the Environmental Health Standing Committee of the Australian Health Protection Principal Committee.

## Environmental health's important role

So, what do I mean by 'environmental health'? It is simply about identifying and managing risks to health from the physical environment. For those with an interest in the history of public health, it is probably one of the oldest parts of any health department. The 19th and early 20th century public health agendas were focussed on sanitation, hygiene, safe food and medicines, poisons control, and the control of noxious industries.

These challenges were thought to have been solved, and certainly the increases in life expectancy due to the provision of safe food, water, human waste, and environmental pollutants through town planning and emissions controls are there to see. Further, over the 20th century, this environmental health agenda was taken up across government with many non-health agencies tasked with managing these risks, including town planning, water management, and occupational health to name just a few.

So why is environmental health still so important and what does a CDC need to focus on? The old problems were never 'solved'. Rather, the problems have reemerged in a different context. Take 'noxious fumes' as a case in point. The most significant environmental problem of the 21st century is climate change arising from the combustion of fossil fuels producing carbon dioxide and other sources of greenhouse gasses. The challenge of safe water is still not solved, particularly in rural communities.

When one looks at good national public health leadership models in other countries, environmental health (both science and workforce) is integrated within their national public health agency model. The US and UK both have a broader remit and include issues such as response to climate change risks, chemicals, and radiation safety.

### Air pollution and PFAS

In recent years, Australia's public health system was caught out by two significant environmental health issues and the lack of investment in environmental health science, namely, the health effects of air pollution and PFAS (Perfluoroalkyl and Polyfluoroalkyl Substances).

The widespread bushfires across eastern Australia in 2019-20 saw differing health advice across jurisdictions being provided to the public. This included advice on whether face masks were useful, and whether outdoor activity needed to cease and at what pollution levels.

The emergence of the PFAS, mainly from use of certain firefighting foams, has been a costly challenge for industry, health, environment, agriculture, defence, and other agencies. It caused significant mental health and financial impacts on local communities who were faced with contamination of their land and water sources.

While these issues are perhaps not as major as the COVID-19 pandemic, they were certainly more significant and more costly issues than a typical run-of-the-mill disease control incident.

## What is environmental health?

### Examining a massive influence on our health: The Environment

#### What is environmental health?

Environmental health is a branch of public health that monitors the relationship between human health and the environment, examining aspects of both our natural and manmade environment and their effect on human wellbeing.

### What is an example of environmental health?

Environmental health is a broad area of study — everything from the climate to the food we eat to the air we breathe plays into environmental health. A few specific examples include:

- Air pollution: Living near factories or heavy traffic worsens air quality and leads to health impacts on the lungs and heart such as asthma and increased risk of heart attacks or stroke.
- Water contamination: Drinking lead-contaminated water can cause IQ loss, behavioral issues, learning disabilities and more. Infants and young children are most at risk.
- Toxic chemicals in consumer products: Phthalates, a class of chemicals that are widely used in consumer products, are known endocrine-disruptors, meaning they hijack your body's hormones and can cause a wide array of health impacts including increased risk of cancer and fertility issues.

### What is the role of environmental health?

The role of environmental health research is to examine areas of the environment that impact our health so that we can make personal and policy changes to keep ourselves safe and improve human health and wellbeing.

# Why is environmental health important?

Environmental health impacts every one of us.

We reap the benefits of clean air, clean water, and healthy soil. If our environment is unhealthy, with toxic chemicals saturating our resources and pollution abundant, then our health also suffers.

It is also an important field of study because it looks at the "unseen" influences on your health.

Many individuals may not associate their health problems with air or water quality, or with what clothes they wear, makeup and household goods they use, or food they eat.

That's because not every example of environmental health problems are obvious: some chemicals, for example, build up slowly over time in your body: a small dose may not seem to bring harm, but repeated small doses can lead to later impacts.

- BPA absorbed through plastic containers, cans, receipts, etc. lingers in the body and the build-up over time increases risk of cancer, diabetes, liver failure, and more.
- PFAS are known as 'forever chemicals'— they don't break down and are widely used, so small exposures are frequent and contribute to immune system and reproductive damages, heightened cholesterol levels, and more.
- Mercury from eating seafood and shellfish can impact neurological development of fetuses in the womb, and populations that regularly consume mercury-heavy seafood have

shown mild cognitive impairment.

Also, individual susceptibility can differ: for example, one member of a household can experience illness, asthma, migraines, etc. from chemicals found in their water supply while another member of the same household is just fine, such as the case in a young girl's reaction to benzene in her water from living near fracking wells.

Certain variables play a role in susceptibility and level of adverse health effects such as age, gender, pregnancy, and underlying health conditions. Studies suggest fetuses, infants and children are much more at risk to experience lifelong health problems from toxic chemical exposure.

Rate, duration, and frequency of exposure to toxic chemicals and other influences from our environment all factor into our health.

Good environmental health = good human health.

### New Zealand Institute of Environmental Health (NZIEH)

Kia Ora Aussie friends,

Winter has officially ended and we hope for some settled spring weather here in NZ after several parts of the country have endured rare weather events causing significant flood damage.

Meanwhile, our virtual events have been going strong here in NZ - we recently held a 3 day webinar series with 130 registrants for each session.
